



## USAJOBS Program Office Staffing Integration Framework and Single Sign On UAT (Test Environment) Registration Form

To facilitate vendor connectivity to USAJOBS 3.0, the Staffing Integration Framework (SIF) and Single Sign On (SSO), please complete the attached form. Upon approval of this request, the vendor will be granted access to the USAJOBS 3.0 UAT (Test) environment. The SIF and SSO are supported by the USAJOBS Program Management Office (PMO) and the OPM Human Resource Tools and Technology (HRTT) organization.

There are three types of access that may be requested. Vendors may request access to SSO only for federated authentication, SIF for full USAJOBS integration or both. SSO and the SIF provides for a comprehensive and standard integration environment for data transaction integration between information systems and USAJOBS. The test platform allows vendors to rigorously and transparently test communication, functionality, and compatibility with USAJOBS 3.0 during their development life cycle(s). Any data collected, stored, processed, and transmitted during testing must be **non-production**, dummy data generated solely for evaluation of the SIF.
